Expert Witnesses: Hired Guns

Once you get to trial, there's a good chance you'll get into the Joe Friday/Dragnet approach of "just the facts ma'am".

If you hire an expert, there is also the personality issue. You hear the story about the attorney who got upset because he liked the opposing expert who was making his point during pretrial matters. The expert had a great personality, and the attorney knew that he liked him, and since he was on the other side, then once he got to trial he was toast. Attorney Fees Provisions: One sided clauses with two-sided consequences.
