# Nuclear Waste, Recyclable Materials, and Wall Street

### Nuclear Waste: Sliding into recyclable materials

As has been reported, Congress has overridden the governor of Nevada's veto of the establishment of a nuclear waste dumping facility at Yucca Mountain. The vote was only possible due to a unique provision in the law that allowed any senator to call for the vote, going over the head of the Democratic leadership. service which, almost unimaginably, could get worse if you complain. The local governments choose not to utilize the tonnage tax which is used by the City of Portland, which has received national recognition for its recycling efforts. Meanwhile, you see your mixed recyclable loads get landfilled instead of recycled, since many of these franchisees own their own landfill. They thus get paid twice, once for the haul and once for the dump. It's always more fun to get paid twice than once

#### ... and so, what to do?

Remarkably, many businesses hold this real weird belief that the American free enterprise, ought determine who gets their business and enters upon their property to remove these mixed recyclable materials which are deposited into dropboxes by the A hauler client, also businesses. motivated by this belief, challenged this practice in federal court, where we won. However, the esteemed Ninth Circuit Court of Appeals in San Francisco recently reversed and ruled in favor of the local governments.

We have thus filed a petition with the United States Supreme Court to accept review of this case. The odds are against us, since the Supremes take only a fraction of the cases that are laid at its doorstep. Still, we had come this far, and you don't get what you don't ask for. Also, a few years ago the Supremes reversed 27 out of 28 of the Ninth Circuit cases that it accepted. Now there's something to raise your comfort level if you live in the western U.S. of A.

Meanwhile, while not common knowledge and not Yucca-bound, nuclear waste and radioactive materials are being transported around the country, by both truck and rail. Just don't put the stuff in dropboxes in Oregon and outside of Porltand or your you'll have local county commissioner or city council person knocking on your door.
