# Weight Mile Tax

An item related to fuel prices is Oregon's weight mile tax. Most of you know that Oregon is one of the few states in the nation that still has a weight mile tax. Idaho's tonnage tax was ruled illegal last year by the courts, so that state has dropped out. The American Trucking Associations has filed a lawsuit challenging the Oregon tax. "Summary judgment" motions have been filed, whereby the court was asked to rule, assuming, your honor, for the purpose of discussion only, that even if all of the lies asserted by the other side are true, that as a matter of law the other side still loses, the moving party wins and there is no trial. The court denied the motions, and a trial will be held within the next few months when the lies, I mean assertions, will get sorted out.

The weight mile tax opponents have long argued that the tax is expensive to administer, both by the carriers and by the state, and that it is easily evaded. They want a fuel tax that is easily collected, with much lower administrative costs and that is tougher to evade. Triple A and the railroads have opposed the change. Now the matter is up to the courts.
